# 1. Executive Summary

FeedOracle is a B2B data infrastructure provider delivering blockchain sustainability data to regulated institutions. Our DAP protocol provides cryptographic proof of data delivery for regulatory workflows.

## The Opportunity

MiCA Article 66 requires 10,000+ CASPs to disclose sustainability information. Similar regulations emerging in UK, Singapore, Japan.

## Our Solution

54+ networks, verified sources (Cambridge, CCRI, DNV), DAP anchored on 4 chains.

## 2. The Problem

### Regulatory Pressure

MiCA requires sustainability disclosure for all crypto-assets. Non-compliance carries significant penalties.

### Data Fragmentation

Blockchain sustainability data scattered across papers, reports, databases. No single API source.

### Verification Gap

Traditional data delivery lacks provenance. Auditors cannot verify what data was received or when.

## 3. DAP Protocol

Cryptographic proof of data delivery, timing, and integrity.

### How DAP Works

- \* SHA-256 Response Hashing
- \* Hourly Merkle Aggregation
- \* Multi-Chain Anchoring (4 chains)
- \* Independent Verification

Deployed: Polygon, Base, Arbitrum, Ethereum - all live

# 4. Technology Architecture

Four-layer data infrastructure:

Layer	Function
4: Attestation	DAP multi-chain anchoring
3: Disclosure APIs	MiCA/CSRD formatting
2: Indicators	Normalized metrics
1: Raw Data	Third-party aggregation
